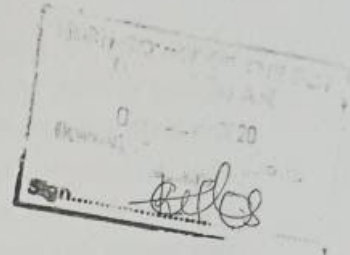

CHARGE
COUNT ONE

That you **ABDULMUMUNI DANGA 'M'** on or about the 29th day of March, 2020 in Lokoja; within the jurisdiction of this Honourable Court had carnal knowledge (sexual intercourse) of Elizabeth Onyenyi 'F' without her consent; and thereby committed an offence contrary to section 1 (1)(2)(3) of the Violence Against Persons (Prohibition) Act, 2015.

COUNT TWO

That you **ABDULMUMUNI DANGA 'M'** with other persons now at large; in Lokoja, within the jurisdiction of this Honourable Court did wilfully inflict physical injury on Elizabeth Onyenyi 'F' by flogging her with electric cable wire; and thereby committed an offence contrary to section 2 (1), (3) of the Violence Against Persons (Prohibition) Act, 2015.

COUNT THREE

That you **ABDULMUMUNI DANGA 'M', SUCCESS OMADIVI 'F'** with other persons now at large; on or about the 29th day of March, 2020 at Lokoja; within the jurisdiction of this Honourable Court, did coerced one Elizabeth Onyenyi

to kneel down by torturing her; and thereby committed an offence contrary to section 3 of the Violence Against Persons (Prohibition) Act, 2015.

COUNT FOUR

That you **ABDULMUMUNI DANGA 'M'**, **SUCCESS OMADIVI 'F'** with other persons now at large; on or about the 29th day of March, 2020 at Lokoja; within the jurisdiction of this Honourable Court did create or falsify a Facebook chat purporting same to be a chat between Elizabeth Onyeniyi 'F' and unknown person where Elizabeth Onyeniyi 'F' confirmed that she was not raped; and there was no test done at the hospital because the doctor was scared to issue report so that she will not lose her job; and thereby committed an offence contrary to section 7 of the Violence Against Persons (Prohibition) Act, 2015.

COUNT FIVE

That you **ABDULMUMUNI DANGA 'M'** with other persons now at large; on or about the 29th day of March, 2020 at Lokoja; within the jurisdiction of this Honourable Court did falsify an audio recording purporting same to be the audio of Dr. Chinonyerem Welle, Medical Director, Police Hospital, Area 1, Garki, Abuja saying that she issued medical report for the rape and assault of Elizabeth Onyeniyi 'F' unlawfully; and thereby committed an offence contrary to section 7 of the Violence Against Persons (Prohibition) Act, 2015.

COUNT SIX


That you **ABDULMUMUNI DANGA 'M'**, **SUCCESS OMADIVI 'F'** with other persons now at large; on or about the 29th day of March, 2020 at Lokoja; within the jurisdiction of this Honourable Court did falsify an audio recording purporting same to be a lady talking to another female saying that Elizabeth Onyeniyi 'F' confessed to her that she was not raped by the Defendant, **ABDULMUMUNI DANGA 'M'** but that it was **Natasha** that asked her to say she was raped; and thereby committed an offence contrary to section 7 of the Violence Against Persons (Prohibition) Act, 2015.

COUNT SEVEN

That you **ABDULMUMUNI DANGA 'M'** with other persons now at large; on or about the 29th day of March, 2020 at Lokoja; within the jurisdiction of this

Honourable Court did falsify an audio recording purporting same to be the audio of Dr. Chinonyerem Welle, Medical Director, Police Hospital, Area 1, Garki, Abuja saying that she issued medical report for the rape and assault of Elizabeth Onyenyi 'F' unlawfully; and thereby committed an offence contrary to section 7 of the Violence Against Persons (Prohibition) Act, 2015.
